Notice: CNRS contribution to the Belmont Forum Arctic CRA is an in kind contribution through the scientist and technician salaries involved in the selected projects and the access to lab and field infrastructures. It is complementary to the French Agence Nationale de la Recherche (ANR) funding contribution. CNRS has official ongoing Arctic cooperation in North America with Canada, especially through the joined international lab Takuvik with Université Laval, and USA, as participant of ArcSEES NSF program, and in Europe with JPI Climate-Arctic and ECRA-Arctic consortiums and with Russia through international cooperative initiatives. CNRS is also one of the main member of the board of the French Polar Institute which is co-operating the AWIPEV station in Svalbard with the Alfred Wegener Institute of Bremerhaven and operates the Marion-Dufresne research vessel.

Eligibility and national funding modalities:

The project proposal will be declared eligible if the consortium includes at least one French partner belonging to the "research organization" category.

Moreover, the project proposal will be declared ineligible if CNRS establishes that it is:

- "similar" to a project that has already been funded by CNRS (any of its institutes)
- "non-unique".

National eligibility and specific requirements for French scientists to participate in the call: The Centre National de la Recherche Scientifique (CNRS) is a government-funded research institution, under the administrative authority of France Ministry of High Education and Research. CNRS was commissioned by the Minister of Higher Education and Research to mobilize and organize the French scientific community to address these fundamental issues. Several research organizations and institutions are going to be involved in this process during the building up of the French Arctic Initiative led by the National Institute for Earth Sciences and Astronomy (CNRS/INSU). A scoping exercise involving all the French scientific community is presently defining 13 scientific priorities with increasing degree of integration but covering the 5 main themes of the Belmont-Forum CRA Arctic call

It is then expected that applications to this call will be Collaborative Research Grants with the consortium composition as defined in the call document.
