### Eligibility and national funding modalities:

### **National Eligibility Rules**

Eligibility criteria and eligible costs must adhere to the standard rules and guidelines of the Swiss National Science Foundation (Funding regulations art. 8 and 13, 14 and 19).

### **National Eligibility Costs**

Applicants may not apply for payment of their own salaries. Eligible costs comprise:

- personnel costs (salaries and social security contributions for scientific and technical staff),
- research costs (expendable items and maintenance, travel costs and field expenses, conference- and workshop-related costs), and

All eligible costs must be linked to the project (Funding regulations, art. 19; General implementation regulations for the Funding Regulations, chapter 3). If you wish to have positions for doctoral candidates covered by the grant, please refer to the salary rates of the SNSF. If you wish to have postdoctoral or technical posts covered by the grant, please refer to the SNSF salary rates of your institution. If your institution does not have its own salary rates, please contact one the financial officer of the Programmes Division of the SNSF.

### **Compliance with the goals of National Research Programmes**

Projects with Swiss partners have to be in compliance with the goals of either the National Research Programme "Sustainable Use of Soil as a Resource" (NRP 68) or "Healthy Nutrition and Sustainable Food Production" (NRP 69). Proposals must reflect one of the programme's objectives and comply with its overall framework. To ensure the compliance with the goals of NRPs, all **pre-proposals with Swiss partners** will be subjected to the corresponding Steering Committee for a suitability check. This is eligibility check is carried out in addition to the review

by a panel of experts based on published selection criteria. Objectives and research topics of the two NRP are formulated in the respective implementation plan.
