AllEnvi – French alliance for environmental research

Participating partner:

This call is supported by the French alliance in research for environment, AllEnvi, through the French Institute of Research for Sustainable Development (IRD)

Key components of eligibility and partner funding modalities are cumulative – and in addition to those mentioned in the call text – and are summarized as follows:

- Consortium should include at least one partner from an IRD joint research unit
- Only research applicants from the proposed countries are eligible to submit proposals (see below)
- Funding request to AllEnvi-IRD must be up to 40 K€ per project
- AllEnvi-IRD retains exclusive rights to make final award decision for AllEnvi-IRD funds

Available funding:

The contribution of AllEnvi to the Belmont forum CRA for Pathways to Sustainability is made through its members that gather almost 20,000 scientists (national research institutes, universities) in the field of environmental sciences.

AllEnvi-IRD contribution to the CRA concerns several ways of cash and In-kind contributions conditional on the participation from developing countries in the projects:

- Through the funding of foreign teams' expenses related to the project including personnel, capital equipment, consumables, materials, services, travel, miscellaneous, and applicable indirect costs
- Through the access to numeric infrastructures managed by IRD providing access to online platforms

Depending on all conditions of eligibility and peer review being met, the total budget allocated by AllEnvi-IRD for this call will be up to 80 k€ in cash (according to exchange rates at time of funding).

Eligibility of proposals

- Only institutions registered in the following countries are eligible to submit proposals: Algeria, Benin, Bolivia, Burkina Faso, Burundi, Cambodia, Cameroun, Central African Republic, Côte d'Ivoire, Democratic Republic of the Congo, Ethiopia, Gabon, Gambia, Guinea, Haiti, Indonesia, Laos, Madagascar, Mali, Morocco, Mauritania, Niger, Senegal, Chad, Togo, Tunisia, Vietnam.

- Only proposals including partners from French joint research units (UMR) under protective administration of IRD (so called tutelle in French) are eligible. A list of UMR is available at <https://www.ird.fr/la-recherche/unites-de-recherche2/unites-mixtes-de-recherche>
- Funding request to AllEnvi-IRD must be up to 40 K€ per project

Funding modalities

- Recipients of funding by AllEnvi-IRD should comply within the IRD policy and guidelines for the use of the funds
- The intention of request support from AllEnvi-IRD numeric infrastructures has to be declared as soon as possible. Note that the access to numeric infrastructures is subjected to the availability at requested time and the agreement with the leader of the research infrastructure
- An up to 6 months no-cost extension may be possible upon request by the partner to Allenvi-IRD with clear justification. AllEnvi-IRD will assess such requests and decide to grant or not such an extension and its length (with a maximum of one year)
