	 For the applicant a) Be Brazilian; if foreign, hold a permanent visa; b) Be resident in the state of Amazonas; c) Have a formal relationship with a research and/or higher education institution, public or private non-profit research center, with headquarters or permanent unit in the state of Amazonas, for a period longer than the duration of the project; d) Have the consent of the head of the applicant's institution or its legal representative at FAPEAM (with an act of designation), proving that the applicant has been linked to the institution for more than the duration of the project.
	For the institution a) Be located in the state of Amazonas and fit one of the following profiles: a.1) Public or private, non-profit research and/or higher education institution; a.2) Public or private non-profit scientific, technological and/or innovation research institution or center.
	Other criteria may be required when submitting the proposal to FAPEAM.
